Nicholas Trucking Invests in Propane

Nicholas Trucking has invested in clean, safe, and economic propane to power their supplemental USPS Routes





With help from EP-ACT, Nichols Trucking Secured a \$93,000 in funding from Pennsylvania Department of Environmental Protection Driving PA Forward program

With the funding, they secured three Ford F-750 propane vehicles with an additional five trucks planned within the year

Propane vehicles emit fewer greenhouses gases, smog, and hydrocarbons. The new engines are 90% cleaner than the EPA's most stringent standards

2023 Clean School Bus Rebate Program

The EPA's Rebate program offers at least \$500 million in funding for clean school buses and zero-emission school buses with the potential to modify this figure based on the application pool and other factors

Applications for the program are due by 4 p.m. ET on January 31, 2024

EPA is also working closely with the Joint Office of Energy and Transportation (Joint Office) to provide school districts with support as they plan for and implement adding electric school buses to their fleets..

Alternative Fuel Corridors

Round 7 of the Bipartisan Infrastructure Law's AFC funding

As part of the Bipartisan Infrastructure Law (BIL), the Department of Transportation is required to invest in Alternative Fuel Corridors (AFCs)

The Federal Highway administration reviewed and evaluated applicants in round 7 of nominations submitted in may of this year. EP-ACT working in conjunction with PennDOT will assist the implementation of PAs newest AFCs.

Round 7 Designations Include

- **EV Charging**: Designations in 11 States, American Samoa, Commonwealth of Norther Mariana Islands, Guan, and Puerto Rico
- Hydrogen: Designations in 13 states
- **Compressed Natural Gas (CNG)**: Designations in 1 State
- Liquified Natural Gas (LNG)
- Propane: Designations in 1 State

Corridors must support freight and goods movement (Freight EV Corridors). In the Request for Nominations, FHWA proposed the National Highway Freight Network as the preliminary designation for Freight EV Corridors, with an option for States to make recommended changes.



National Electric Vehicle Infrastructure - Round 1A Priority Locations



PennDOT has released the draft NEVI Round 1A Priority Locations map. The map is interactive and can be found through the link below

The map displays the corridorgroups that will compete for funding, the priority level of each corridor-group, and 1-mile polygons off of each exit and highway segment so viewers know which locations are eligible to apply



Historically, there has been somewhat of an inverse relationship between vehicle miles traveled (VMT) and gasoline prices. In the past, a rise in gasoline prices was typically followed by a decrease in discretionary travel, leading to a decrease in VMT. This set up a pattern where the gasoline price and VMT trendlines almost mirrored each other. In 2020, during the COVID-19 pandemic, there were severe disruptions in VMT that broke that pattern. Gasoline prices and VMT were both going down at the same time from March 2020 to March 2021 and then both increased thereafter. In early 2022 both gasoline prices and VMT experienced another large decline with the VMT decline preceding the decline in gasoline prices.
